Approval of Agenda: Motion to approve the amended agenda by Guttersohn; seconded by Campbell. Voice Vote: Ayes: Kinaitis, Campbell, Chapman, Guttersohn, Orr and Bessenbacher. Nays: None. Motion Passed. Agenda amended to add AGS (B-old business).

Approval of Minutes: Approval of July 11, 2022 minutes as written; motion by Kinaitis and seconded by Guttersohn. Voice Vote: Ayes: Kinaitis, Campbell, Chapman, Guttersohn, Orr and Bessenbacher. Nays: None. Motion Passed.

Committee Reports: Budget: Reed explained the amendments for \$120,592.00. Ketchum asked council about their comfort level and discussion on subject took place. Orr motioned to approve the requested amendments for \$120,592.00; seconded by Kinaitis. Roll Call Vote: Ayes: Kinaitis, Campbell, Chapman, Guttersohn, Orr and Bessenbacher. Nays: None. Motion Passed

Police Report- Guttersohn read report.

DPW Report – Warren explained the dam inspection for 13,000.00 in order to meet State requirements. Orr motion to accept the Spicer contract for dam inspections in the amount of \$13,000.00; seconded by Chapman. Roll Call Vote: Ayes: Kinaitis, Chapman, Guttersohn, Orr and Bessenbacher. Nays: None. Motion Passed. Warren also requested GL numbers for each dam and Reed explained trying to put dams under major streets, the State said we could not. Warren requested shoulder stone for \$1,500.00 and 2 tree removals for \$2,800.00. Guttersohn motion to approve the purchase of shoulder stone for \$1,500.00; seconded by Chapman. Bessenbacher. Nays: None. Warren requested dam level sensor for \$5,995.00 to buy or to lease for \$1,495.00 per year. Discussion took place on subject and council tabled until September.

Cemetery Report: Bessenbacher read report. Discussion took place on the unauthorized benches in the cemetery and Johnson said just pull them off if you have rules prohibiting them and send letter. When they pick them up have them sign receipt. Reed asked if we could do pop can collection for donations toward flag holders and Johnson said yes.

DDA Report: Reed said DDA looking to hire a recording secretary for \$45.00 per meeting.

Commissioner Report: Howard said quiet month. We have hired a replacement employee. Repairing the stone on the Court House and explained the process.

911 Commission: None

Old Business:

PayGov.US-Debit/Credit Card Payments: Reed explained company in business for 15 years and it is month to month. There is no cost to the Village only a surcharge for the individual using it (example of our \$228.19 water bill would cost \$7.00-\$10.00 to pay using debit/credit card). Bessenbacher suggested trying for 6 months. We would receive real time reports. Guttersohn motioned trying PayGov.US for 6 months; seconded by Chapman.
